

Employment Opportunity – Elliot Lake, Ontario Labourer/Truck Driver

OUR COMPANY:

Denison is a uranium exploration and development company with interests focused in the Athabasca Basin region of northern Saskatchewan. Denison is also engaged in mine care and maintenance and environmental services through its Closed Mines Operations and is the manager of Uranium Participation Corp., a publicly traded company which invests in uranium oxide and uranium hexafluoride.

Denison's Closed Mines Division, a division of Denison Mines Inc. (DMI), is a trusted industry leader in care and maintenance of closed mines, mine closure planning, and mine rehabilitation. The main office for the Closed Mines Division is located in Elliot Lake, ON, with satellite offices in Whitehorse, YT, and Rouyn-Noranda, QC.

THE ROLE:

The position of **Labourer/Truck Driver** is responsible for performing long term care and maintenance (C&M) activities at various projects primarily on closed mine sites in the Elliot Lake area. This role provides labour support for:

- Maintenance and repair of vehicles and equipment, power tools, pumps and electrical generators
- Application of herbicide products for vegetation control on dams and spillways.
- Carpentry and concrete formwork activities for all types of infrastructure construction.
- Mine site infrastructure decommissioning and demolition involving asbestos removal, cutting and welding, rigging and removal of electrical equipment.
- Pipefitting of all types of pipe and fittings and welding of HDPE pipe.

This role is being offered as a casual / seasonal hourly position based in Elliot Lake, Ontario. All applicants must be eligible to work in Canada.

OUR IDEAL CANDIDATE:

You are flexible, hard-working and dedicated to performing work in a safe manner. You are able to function well either working independently or with a team. This job requires physical and outdoor duties. In addition, you possess the following skills and attributes:

- Safety minded follows Company safety policies, wears appropriate PPE for the task, and participates in safety improvement programs;
- Holds a valid Class AZ driver license (preferred), with clear driver's abstract;
- Licensed for application of vegetation control products in accordance with the provincial Pesticides Act (Licensed Herbicide Applicator);
- Strong preference will be given to candidates with one or more of the following: Class 9 herbicide certificate, Class A driver's licence, industrial welder or other relevant trades
- Proficient in the use of ATVs and Snowmobiles;
- Physically fit (able to walk and/or snowshoe up to 1/2 km through forested areas);
- Able to carry backpack loads of up to 7 kg for 1/2 km;
- A competent computer user (familiar with Microsoft Outlook, Word and Excel);

- Able to read and understand instructions and procedures;
- Effective writing and communication skills;
- Able to work in a team environment; and
- Punctual, self-motivated and independent work habits.

YOUR RESPONSIBILITIES:

- Perform vehicle circle checks complete with all related documents as well as routine maintenance on the truck and trailer;
- Complete loading and unloading functions (hooking up quick connect couplings for discharge hoses);
- Drive tractor trailer transportation units in accordance with the Highway Traffic Act (HTA);
- Operate offloading blower and following lime slurry loading and delivery procedures;
- Apply vegetation control products in accordance with the provincial Pesticides Act (Licensed Herbicide Applicator);
- Assist with maintenance, troubleshooting and repair of industrial mechanical equipment, vehicles, power tools, pumps etc.;
- Snow removal;
- Actively participate in Job Hazard Assessments, Safe Work Plans, and other aspects of the safety program
- Participate in the investigation and development of corrective and preventive actions, for safety related matters;
- Review and assist in updates to operating manuals, procedures and forms, and
- Operate and conduct routine maintenance of mobile equipment including loaders, excavators, forklifts, skid-steers when required.
